The degree awarded to the student is dependent on the major program(s) completed. Candidates completing a major program in the humanities or the social sciences receive the B.A. degree; those completing a major program in the fine arts receive either the B.A. or the B.F.A. degree. The B.S. degree is awarded to candidates completing major programs in the sciences and in mathematical economics. Candidates completing major programs in anthropology, economics, linguistics, and mathematics receive either the B.A. or B.S. degree.

Although students usually complete the requirements for one degree, some elect to complete two degrees. In addition, joint-degree programs involving the completion of degree requirements in more than one of the undergraduate schools are available. Some of these programs allow a student to begin work toward a professional degree in the fourth year of study. Prior planning and consultation with advisers are required to successfully complete a joint-degree program.

DEGREE REQUIREMENTS

The credits presented for an undergraduate degree must satisfy the core curriculum, school specific core curriculum and major requirements described within the appropriate program of study. Each candidate for degree is required to have completed at least 120 credits of academic work and to have achieved a 2.000 cumulative grade-point average at the university and in the major. At least 66 of the 120 credits must be earned in courses above the 100 level. To qualify for two baccalaureate degrees from any of the schools, a student must complete a minimum of 150 credits (75 credits completed at Tulane University) at least 82 of which must be above the 100 level and satisfy all requirements for each degree and each major. A candidate also must file a degree application

for each degree at least two semesters prior to the anticipated date of graduation.

Undergraduate students who have not completed the writing core requirement by the end of the second semester of enrollment may not early register for the following semester and may not return to the College until this requirement has been fulfilled. Students who have not completed the foreign language requirement by the end of the fifth semester will not be permitted to register for the following semester. They may not enroll in the College until this requirement has been fulfilled. Students who have not completed the quantitative reasoning requirement by the end of the fifth semester in the College will not be permitted to register for the following semester and may not enroll again in the College until the requirement has been completed. These policies apply to all students, including those who contemplate leaving for any reason prior to graduation.

The recommended semester program consists of 15 credits to 19 credits. All degree candidates must have completed the last 30 credits of coursework in residence in the school and a minimum of 60 credits at Tulane University. Students who participate in a Tulane study abroad program or other Tulane-sponsored program in the senior year are earning Tulane grades and credits and, therefore, are considered to be meeting the senior residency requirement.

Subject to approval, students may count a maximum of 15 credits of summer work at Tulane, or up to six credits of summer work from other four-year, regionally accredited institutions, as part of their last 30 credits that must be completed in residence. Other school- or program-specific restrictions may apply. Students are encouraged to consult with their advisers.

A maximum of nine credits from the School of Continuing Studies may count toward graduation requirement. Full-time students may NOT satisfy degree requirements by taking the following offerings of the School of Continuing Studies [which are available only to part-time students].

- ACTG prefix all accounting courses
- BSLW prefix all business law courses
- FIAN prefix all finance courses
- MGMT prefix all management courses
- MKET prefix all marketing courses
- CPST all computer systems and technology courses
- CRST all casino resort studies courses
- HURM all human resource development courses
- PRLS all paralegal studies courses

Full-time students interested in these areas of study may satisfy degree requirements by taking courses offered through the A.B. Freeman School of Business.

At any time, students can access automated degree audits from the University Registrar's website (http://www.registrar.tulane.edu) showing all completed courses and indicating the general degree requirements and major requirements that remain to be fulfilled before graduation. Students should discuss their degree audits with their advisers and report errors to the appropriate dean's office as soon as possible. Each student is responsible for knowing the exact degree requirements as stated in the school sections of this catalog and for enrolling in appropriate courses to satisfy those requirements.

ADVANCED STANDING AND EXEMPTION

Although the university awards placement or credit to students who have earned sufficiently high scores on AP or IB exams, students not in these programs also may have special expertise in a subject area and may already be proficient in English or in a foreign language. Consequently, these departments offer proficiency examinations. Students who demonstrate proficiency in English receive credit for ENGL 101. Students, who prove

proficient in a foreign language through a sufficiently high score on the College Board Achievement Test or on the departmentally administered proficiency exams, are exempted only from the competency portion of the foreign language requirement only, with no credit awarded; all students must take at least one foreign language course at Tulane University. Exemption may be given in other departments on an individual basis.

ADVANCED PLACEMENT (AP)/INTERNATIONAL BACCALAUREATE (IB) CREDITS

Advanced placement or college credit is awarded to students who receive the required scores on the College Board AP exams as established by Tulane University academic departments. It is the student's responsibility to ensure that an official report of the AP test scores is sent to Tulane University.

When planning their fall schedules, first-year students should not enroll in courses for which AP credit is expected. AP credit does NOT count toward the minimum or maximum course load or toward the minimum number of earned credits required to remain in academic good standing. No more than four credits of English and no more than four credits of a single modern foreign language will be awarded to any student, even if the student has high scores on the language <u>and</u> literature tests.
