BIOGRAPHICAL NOTE:

Mary Elizabeth Gehman was born in 1943 and raised in a small Mennonite community in Buck's County, Pennsylvania. Her religious heritage propelled her lifelong commitment to feminism. At the age of twenty-one, she had perceived the second-class status of women in the Mennonite Order and decided to leave the church. After graduation from Millersville State College with a B.A. degree in secondary education and German, she taught for a year in a junior high school.

The year 1967 brought her to New York City, to a new career as a social worker, and to the electric stirrings of the women's movement. The consciousness-raising sessions she attended began to plant the roots of her feminist activism, but the pinnacle of these early days was certainly the protests of the Miss America Pageant in 1968 and 1969, in which she participated along with Gloria Steinem, Robin Morgan, and Flo Kennedy.

In 1970 Mary Gehman moved to New Orleans. Although the feminist activism did not compare with that of New York City, Mary Gehman's energy did not dull throughout the decade with active involvement in the women's community locally as well as the National Organization for Women. Her career shifted from social work to journalism in the early seventies. With a Bachelor's degree in Journalism from Loyola University in 1972, she worked as a reporter for the Times-Picayune, but the sexism of the newspaper made her stint there a brief one. She found an outlet for her journalistic talents through her involvement with the Distaff, a women's newspaper. Because there existed no feminist newspaper in the South, Mary Gehman and a few others transformed the broadside of Barbara Scott's campaign for state representative into a monthly paper concerning feminist issues. Mary Gehman's energy as editor kept the paper in print for its tenure 1973-1982 (with the exception of July 1975-1979, when it was out of publication).

After the demise of the paper, Mary Gehman became a tour guide. Dismayed at the lack of information available on women in New Orleans, she researched the subject, and her efforts culminated in a book entitled Women in New Orleans, published in 1985. With the completion of her book, Mary Gehman turned her energies to pursuing a master's degree in English, which she received in 1988 from the University of New Orleans. She has taught Freshman Composition at Loyola University and is currently teaching Composition at Delgado Community College.

SCOPE AND CONTENT:

The Mary Gehman Collection consists primarily of materials spanning the years 1976-1986. Mary Gehman's intention was to collect materials published about women during the U. N. Decade for Women, but she expanded the project to include material from both earlier and later periods. The entire collection spans the years 1970-1991 and addresses both national and international issues. Although Ms. Gehman had hoped that the materials be organized by subject, the sheer bulk of the collection dictated that it be organized by type of material, with few subject headings.

Noteworthy in the collection are the following:

• a complete collection of Distaff, the first and only women's newspaper published in

New Orleans; government documents

- government documents, including publications from the national Advisory Council on Women's Educational Programs and the Citizen's Advisory council on the Status of Women
- a large collection of <u>Times-Picayune</u> and <u>Village Voice</u> articles
- almost complete collections of the Atalanta, Communiqu'elles, and Generations journals
- a wealth of material from organizations such as the National Organization for Women, the National Abortion Rights Action League, and Planned Parenthood, organizations Mary Gehman has worked with for many years.

But the primary strengths of the collection are the small press journals and the breadth of subject matter Mary Gehman covered. As it documents the progress and pitfalls of the U. N. Decade for Women, this collection should be a valuable resource for researchers of the 1970's women's movement.

Carton 1 of 14 Distaff Materials NAC-231

<u>Distaff</u> correspondence spans the years 1973-1987, though the newspaper ceased publication in 1982. The correspondence section contains letters, press releases, and submissions for publication.

A complete collection of the <u>Distaff</u> newspaper (1973-1982) is contained in this box. Beginning in 1973 as a broadside for Barbara Scott's (unsuccessful) campaign for State Representative, the paper was published monthly until July 1975 and was restarted in November 1979. It was the first women's newspaper in New Orleans, the only paper that dealt with pressing issues to feminist women such as labor organizing and abortion.

Carton 7 of 14 <u>Village Voice</u> Articles, 1978-1991 NAC-237

The <u>Village Voice</u> contains articles about diverse women's issues such as abortion, birth control, violence against women, and sexuality. One of the paper's strengths is its book/film review section, and many of the articles contained within are reviews of feminist texts, female authors and female directors. The articles are separated into file folders by year.

The journals are arranged alphabetically, with <u>Atalanta</u> through <u>Generations</u> in this box. This series contains numerous small press journals. Of note are almost complete collections of <u>Atalanta</u>, the journal of the Atlanta Lesbian Feminist Alliance (1981-1991); <u>Communiqu'elles</u>, a bi-monthly Canadian journal begun in 1974 and published in Quebec (1981-1989); and <u>Generations</u>, the journal of the Southeast Women's Employment Coalitiona multi-state organization working to achieve job equity and economic opportunity for women (1981-1990).

NAC-240

This material is alphabetized by organization and contains items such as letters, newsletters, and press releases. Of note are extensive materials from the National Abortion Rights Action League (NARAL) and National Organization for Women (NOW), as well as smaller organizations such as Catholics for a Free Choice and Greenham Women Against Cruise Missiles.

Carton 12 of 14 Miscellaneous Materials, 1979-1991

Miscellaneous materials include notices, advertisements, fliers, and the like. This catagory also includes a manuscript written by a one-time student of Gehman, Jo Ann Canaday. The manuscript, entitled "A Study of Five Politically Active New Orleans Women's Organizations--Do they have any political 'clout'?" includes interviews with women from the following local organziations (among others): NOW, League of Women Voters, Women's Political Caucus, YWCA Rape Crisis Center, Women Against Crime. A list of the

women interviewed and their affiliations can be found in the first folder of this manuscript.

Carton 13 of 14 Pre-Organized Box NAC-243

This is the first box Mary Gehman donated to the Women's Center, and she tried to arrange it in subject order. her section consists primarily of loose <u>Times-Picayune</u> news clippings arranged under similar headings to the ones used for the folders of the 1985 <u>Times-Picayune</u> clippings. Tina Thurman-Schwartzwelder originally got Mary Gehman involved in organizing her collection. As Ms. Thurman-Schwartzwelder was doing some news clipping herself, they put some of their material together. Ms. Thurman-Schwartzwelder's articles are pasted on white paper.

Carton 14 of 14 Addendum NAC-244

This carton consists entirely of mailings and clippings, with the exception of one file. (The exception is the file entitled "Distaff--Ideas for Articles, Clippings," which includes notes, correspondence, press releases, and other non-printed matter.) All materials have been placed in acid-free folders and alphabetized according to subject and/or organization. The bulk of the materials is from the period 1988-1992, including much campaign materials from the 1992 elections; however, there is material that dates back to the early eighties/late seventies. Of the newsletters, quite notable is the collection of ATALANTA, the newsletter of the Atlanta Lesbian Feminist Alliance; of the clippings, certainly those of the Village Voice and the Times-Picayune/States-Item. Because of their sheer bulk, the clippings files have not been sorted by subject, although that would be easier for the researcher--perhaps sometime in the future. Also, the clippings remain in their original form--on newsprint--and are in need of reproduction on acid-free paper.

Oversized Box 1 of 3 Distaff--Complete Collection (newsprint) OV-002

This complete collection of the <u>Distaff</u> newspaper corresponds with the photocopies in Carton 1. Because the publication of the newspaper lapsed at times, there may appear to be gaps in this collection. This is not the case as a gap indicates that no issue was published at that time.

Oversized Box 2 of 3 "It's A Woman's World" / "Spectrum" OV-003

In the early eighties, the <u>Times-Picayune</u> printed annually a special section entitled "It's A Woman's World," a directory of local women's organizations. In later years the section was renamed "Spectrum"; however, it continued to represent the same material. This box contains several, although not all, of these annual directories.

Oversized Box 3 of 3 Posters OV-?

The four posters are located in an oversized box in the archives. The first poster is an announcement for a symposium sponsored by the <u>Yale Journal of Law and Feminism</u> entitled "Feminism in the 90's: Bridging the Gap Between Theory and Practice" (1991). The second poster promotes the ERA; it was designed by Helaine Victoria Press in 1985. The third poster is an anti-apartheid poster. The fourth is an Equal Employment Opportunity poster published in 1982 by the Equal Employment Opportunity Commission.

Biographical Note

Mary Elizabeth Gehman was born in 1943 and raised in a small Mennonite community in Buck's County, PA. This experience contributed greatly to her later involvement in ferninism, for within the Order women's role was confined primarily to the home; women could not hold positions of leadership within the Church. Mary Gehman questioned Church teaching and the roles assigned to men and women, eventually making the painful decision at age 21 to leave the Order permanently.

After graduating from Millersville State College with a Secondary Education degree and a major in German, she taught in a junior high school for a year. In 1967, she moved to New York and became a social worker. It was in New York that she first heard of feminism and became active in the movement. She began attending the first consciousness - raising groups, but the turning point in her commitment to feminism occurred when she attended the Miss America protests of 1968 and 1969, along with Gloria Steinem, Robin Morgan, and Flo Kennedy.

Mary Gehman left New York in 1970 and came to New Orleans, where she has remained. She became involved in the women's community in New Orleans and continued her involvement with organizations such as the National Organization for Women. She received a Bachelor's degree in Journalism from Loyola University in 1972 and did a brief stint as a reporter for the <u>Times Picayune</u>, leaving because of the sexism she encountered. But Mary Gehman found an outlet for her journalistic talents through her involvement with the <u>Distaff</u> newspaper, which began as a broadside of Barbara Scott's campaign for State Representative. Mary Gehman and other women involved in the Scott campaign decided to start a women's newspaper in New Orleans, since there was no such paper anywhere in the South. Due to Mary Gehman's consistent, unflagging energy and devotion as editor of the newspaper, it stayed in publication, with the exception of July 1975 - 1979, until its demise in 1982.

After the demise of the paper, Mary Gehman became a tour guide, and was dismayed at the lack of information available on women in New Orleans. She researched the subject, and her efforts culminated in a book, <u>Women in New Orleans</u>, published in 1985. With the completion of her book, Mary Gehman turned her energies to pursuing a Master's degree in English, which she received in 1988 from the University of New Orleans. She taught Freshman Composition at Loyola University during 1989 - 1990, and is currently teaching Composition at Delgado Community College.

Series Description

1. Distaff Materials:

One box

A. <u>Distaff</u> Correspondence spans the years 1973 - 1987, though the newspaper ceased publication in 1982. The correspondence section contains materials such as letters, press releases, and submissions for publication, and is organized accordingly.

B. A complete collection of the <u>Distaff</u> newspaper (1973 - 1982) is contained in this box. This paper was published monthly until July 1975, and was restarted in November 1979. The paper began as a broadside for Barbara Scott's failed campaign for State Representative. Barbara Scott wanted to start a New Orleans newspaper, and her supporters, including Mary Gehman, began the monthly publication in 1983. The first and only newspaper in New Orleans dealt with pressing issues such as abortion and labor organizing.

2.Government Documents:

1970 - 1988, One box

Of note in this box are publications from the National Commission on the Observance of International Women's Year, with material addressing issues such as education, employment, and the ERA; the U.S. Department of Labor; the National Advisory Council on Women's Educational Programs; the Citizen's Advisory Council on the Status of Women; the Department of Health, Education, and Welfare; and the U.S. Department of Health and Human Services, containing information on social security and medicare. The material is arranged alphabetically by organization.

3. News Clippings : 1976 - 1990, One box

This box contains mainstream press clippings, such as <u>Time</u> and <u>Parade Magazine</u>, as well as small press journal articles, such as <u>Radical America</u> and <u>The Militant</u>. It is organized alphabetically.

4. <u>Times Picayune</u> articles span the years 1976 - 1991 and are contained in three boxes. The first box contains the years 1976 - 1982; the second contains 1982 - 1985; the third contains 1985 - 1991. The articles are separated into different file folders by year. For the year 1985, I sorted most of the clippings by subject. The headings I used were Abortion and Birth Control, the Arts, Commentary, Consumer Issues/Finance, Crime/Violence by/against Women, Domestic Issues, Employment/Business, Ethics, Gender Issues, Health, Images of Women, Individual Women, International Women, Literature/Book Reviews,

Miscellaneous, Politics, Sexuality, the Status of Women, and Women's Sports.

5. Village Voice:

1978 - 1984, 1985 - 1991, Two boxes

The <u>Village Voice</u> contains articles about diverse women's issues such as abortion, birth control, violence against women, and sexuality. But one of the paper's strengths is its book/film review section, and many of the articles contained in these boxes are reviews of feminists texts, female authors, and female directors. The articles are separated into file folders by year.

This series is only a sketch of the contents of the box; it does not include every item. But the series does illustrate how I will organize the collection, and it shows the range of materials contained in the collection. Mary Gehman Collection

After almost six weeks of working on the Mary Gehman Collection, I have gone through seven boxes- placing the materials in separate acid-free folders based on types of material. Some of these materials include news clippings, journals, newsletters, pamphlets, and assorted letters and notices. This initial stage of the project has given me a better understanding of what the collection consists of and also suggestions for how to organize it.

My plan at this time is to group the contents together based on type of material, and to place these contents in chronological order by year. I have decided not to retain the original box contents- instead placing related materials in separate boxes. I feel that it is not necessary to retain the original order because the materials were not organized in any particular manner.

I have been organizing Box #4 in the collection in order to estimate the time needed to completely organize one box. In addition, I have made decisions regarding file headings for the collection. The major headings I have at this time are News Clippings, Journal Clippings, Journals, Organizational Materials, Miscellaneous Pamphlets, Requests for Funds/Membership, Distaff Material, Catalogs, Notices and Advertisements, and Miscellaneous. In addition there are materials which do not fit these categories, but which I do not wish to place in a miscellaneous file. I have not decided what to do with them yet. I am not through with this box yet, but I estimate that it will take me between 2 1/2 to 3 weeks to entirely complete one box. Organizing the Times Picayune articles has been the most time consuming aspect of this project.
