



## Contract

In the event that Artist is unable to appear or perform as a result of the physical disability of the Artist (except being under the influence of intoxicating beverages, narcotics or drugs) or act of regulation of public authority, civil tumult, interruption or delay of transporting service, act of God, force majeure or any other cause beyond the control of the Artist or Presenter, then this agreement shall terminate and the Parties hereto shall be released from any and all obligations to the other.

5. In the event Artist or Presenter cancels or otherwise breaches this agreement in a manner not enumerated in Paragraph 4. above, the party in breach shall be responsible for the payment of all costs and expenses incurred by the other party in preparation for the performance(s).
