Re: Notice of Intent to File Citizen Suit Pursuant to Clean Water Act Section 505(b)(1)

To Suiza Foods, Inc.:

The Felicity Street Redevelopment Project, Inc., Aurora Castro Knox, and Betty Baptiste hereby provide Suiza Foods, Inc. ("Suiza Foods"), owners of Brown's Dairy, located at 1300 Baronne Street, New Orleans, Louisiana, with this Notice of Intent to File Suit pursuant to Section 505(b)(1) of the Clean Water Act ("CWA"), 33 U.S.C. §1365(b)(1)(A), and 40 C.F.R. §135.2

This notice is being provided to Suiza Foods because Suiza Foods has violated, and will continue to be in violation of CWA, specifically CWA's sections regarding the discharge of any pollutant by any persons, without a permit.

Violations:

Section 402(a) of the CWA requires that the Administrator of the Environmental Protection Agency ("EPA") permit any discharge of a pollutant. The EPA has delegated to the State of Louisiana, under Section 402(b) of the CWA, the authority to administer and enforce permit requirements for pollutant discharges into waters within the state. 61 Fed.Reg. 47932 (Sept. 11, 1996). Louisiana Revised Statute ("La.R.S") 30:2075 also prohibits any activity, which results in the discharge of any substance into the waters of the state without the appropriate permit. La.R.S. 30:2075. Pursuant to Louisiana Administrative Code ("LAC") 33:IX.2311(A)(1), Louisiana requires permits for the discharge of any pollutant from a point source into the waters of the state. LAC 33.IX.2311.A.1. Suiza Foods has violated and continues to violate Section 402(a) of the CWA, 33 U.S.C. §1342(a), La.R.S. 30:2075 and LAC 33.IX.2311.A.1. by discharging

without a permit leftover biological materials from the Brown's Dairy plant at 1300 Baronne Street, New Orleans, LA into the storm drain sewer system which flows into the waters of Lake Pontchatrain and/or the Mississippi River.

Relief Sought:

- Civil penalties, pursuant to Section 309(d) of the CWA, 33 U.S.C. §1319(d), of up to \$25,000 per day for each alleged violations of Section 402(a) of the CWA;
- Immediate cessation of the aforementioned discharges and illegal activities;
- All reasonable court costs; and
- Any other such relief as may be just and appropriate.

Person Giving Notice:

Federal regulations concerning citizen suit notices of intent to sue require us to provide the names, addresses and telephone numbers of the persons giving notice. 40 C.F.R. §§135.1-3.
